

HEREINAFTER referred to as the 'TRUSTEES' (which expression shall, unless excluded by or repugnant to the context, be deemed to include the trustee or trustees for the time being of these presents and their successors) of the **OTHER PART**.

WHEREAS the settler is desirous of establishing in perpetuity a fund amounting Rs. 10,000/- (Rupees Ten Thousand only) in India for charitable purpose including relief to the poor, education, medical relief and advancement of any other object of general public utility Not involving or carrying on of any activity for profit all over India and for this he is desirous of setting up a Public Charitable Trust for the advancement of the said object in India and whereas the Trustees as above, at the request of the settler, have given their consent to act as the trustees along with the settler for administration of the affairs of the said trust in accordance with the terms and conditions hereafter provided.

WHEREAS the Author/Settler of the Trust desire to irrevocably endowing the Said Fund upon Trust for Public Charitable Purpose, as hereinafter expressed and contained in this presence and in pursuance of such desire have already transferred, paid and handed over the said Property to the Trustees mentioned below.

WHEREAS the Settler is desirous of establishing a Non Profitable, Non Commercial & Non Political Trust for public charitable objects.

AND WHEREAS the trustees have, at the request of the settler, agreed to act as the first trustees of these presents as testified by their being parties to and executing these presents.

AND WHEREAS to fulfill the said desire the Settler has set apart and handed over to the trustees a sum of Rs. 10,000/- (Rupees Ten Thousand only) for initiation of the said PUBLIC CHARITABLE TRUST to be held by the Trustees and hereinafter called the "Trust Fund."

AND WHEREAS at the request of the **SETTLER**, the **TRUSTEES** herein have also agreed to sign their acceptance by joining in the execution of this INDENTURE OF TRUST along with the Settler.

AND WHEREAS it is necessary to declare the objects and terms of the PUBLIC CHARITABLE TRUST, being constituted under these presents.

NOW THIS DEED OF INDENTURE WITNESSETH AS FOLLOWS:

1. That the said "SETTLER" has already handed over, transferred, assigned and given to the "TRUSTEES" a sum of Rs. 10,000/- (Rupees Ten Thousand only) upon Trust along with all future conditions as contained hereinafter and further the trustees are authorised to take and receipt and accept funds from other person or persons including relatives, friends and well-wishers of the trustees and also from any firms, companies, banks, financial institutions, trusts, societies, corporate bodies or from any corner any amount for being added to the Corpus Fund by way of contributions, donations, subscriptions, grants, settlements, loans or financial assistance for carrying out and/or performing any one or more of the objectives for which this trust has been created and established and may send fund on such terms and conditions as may be resolved on majority of votes amongst the trustees from time to time in fulfilment of the PUBLIC CHARITABLE OBJECTIVES OF THE TRUST.

2. NAME :-

The Trust hereby established shall be named as "NAGARIK

ADHIKAR RAKSHA SANGATHAN".

(A Non Profitable, Non Commercial & Non Political Trust for public charitable objects.)

3. REGISTERED OFFICE OF THE TRUST:-

Registered Office (Rented) of the Trust shall be situated at- NAIHATI RAJENDARPUR, P.O.- MADARPUR, P.S.- SHIBDASPUR, DIST-NORTH 24 PARGANAS, PIN CODE- 743166, WEST BENGAL, INDIA, only for Correspondence Purpose and it shall not effected and treated as Trust Property. By a majority of votes, the Trustees may shift the Registered Office to any other Place or to open its Branches to any others places as they decide within India. **OFFICE ADDRESS MENTIONED ABOVE USED** IS ONLY CORRESPONDENSE PURPOSE AND IT IS NOT THE TRUST PROPERTY. FOR

4. AIMS AND OBJECTS OF THE TRUST:-

That the aims & objectives of the trust shall be of general public welfare and other charitable purpose including relief of the poor, education, medical relief and advancement of any object of public utility not involving the carrying on of any activity for profits as defined under the income-tax act, 1961 and / or under any order for the time being in force under the income-tax act, 1961 and / or under any order for the time being in force under the income-tax act and/or any stationary modifications thereof. Besides such objectives in general the trust will mainly work with the sphere of drug and other chemical substance abuse and without prejudice to the generality of the aforesaid and the following shall be deemed to be the principal objectives of the Trust.

That the objects only for Charitable Purposes on defined in Charitable Trust Act 1920 & Income Tax Act 1961, for which this trust is established are:-

- 4.1 To establish, develop, maintain, run and to do all kinds of Education Programs, Health Programs, Agricultural Programs, Environmental Programs, Cultural Programs, Social Welfare Programs and also take Part in all types of State Government & Central Government Projects and /or Programs. To implement the Schemes / programmes of various institutions / departments engaged for development of handicraft sector like KVIC, SIDBI, Ministry of Textile, NABARD, Department of Rural Development, Consumer Forum, Legal Services Authority, Central/State Educational Board/ Council etc.
- 4.2 To Establish, Maintain Develop and Run Schools, Colleges, Beautician Training, Makeup Training, Mehndi Art Training, Nail Art Training, Hair Treatment Training, Dermatology Training, Tattoo Art Training, Fashion Training, Cake Nursing & Paramedical Training, Competitive Exam Preparation Training. To Establish, Maintain Develop and Run Beautician Training Centre, Distance /Correspondence Education, Coaching Centre, Social Service Centre, Industrial Training Centre, Computer Training Centre, IT & ITES Training Centre, Tailoring Training, Nursing & Paramedical Courses, Hotel Management Courses, Hospitality Management Courses, Aviation Courses, Vocational Training Centers, Cultural Course Training Centre, Skill Development Training Centre, Astrological Training Centre, Palmistry, Vaastu, Numerology, Reiki, Yoga, Angel Training, and to help to develop their Self Employment Skills. To study & research modern scientific system of astrology, palmistry, pourohitye, numerology, angel & reiki therapy & healing, tarot cards, Vaastu shastra, yoga, tantra and all religious & spiritual adoration and contribution propagation modernization without profit motive, after getting prior approval from competent authority. To establish centers for employment generation, Personality Development Training, Counseling and Motivation Training, research on Social Up-liftment and welfare activities etc. to all with Special Emphasis to Poor and Unaffordable Student. To do, act, run, promote and organize all types of Meditation Centers and/or Meditation Camps throughout India. To do all kinds of Career related activities, Career oriented Training through institution also with placement guidance & services. The Trust is subjected to provide the certification after successful completion of any course and examination which is conducted by this Trust thereof.
- 4.3 To Establish, Maintain and Run all types of (Like Bengali Medium, English Medium, and Hindi Medium etc.) Pre-School/ Play School, Nursery/ Primary School, Upper / Secondary & Higher Secondary Schools under all Boards. To establish, Develop, run, support, form, maintain and grant aid or other financial assistance to Play Schools, Pre-Primary Schools, Kinder Garden Schools, Primary Schools, High Schools Higher Secondary Schools affiliated by CBSE, ICSE WBBSE, WBCHSE and/or any other Board or Council in India.
- 4.4 To establish, develop, support, maintain, run and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, auditorium, lecture hall, seminar hall, Teachers' Training Colleges like BED Colleges, DED Colleges, JBT colleges, PTTI Colleges, Hotel Management Colleges, Research Study Centres, Law College, Engineering College(s), Engineering Colleges including industrial training centres, ITI Colleges, MBA, MCA Colleges, Colleges, Professional Colleges, Universities, Technical And Non-Technical Institution, Share Trading Training institution(s) and / or other allied institutions Of All Kinds With Hostel And/or Boarding Facility Including Research Institutions For Good Education And Advancement Of Knowledge amongst the public in general. The

Trust would also be empowered to apply for Deemed University whenever it feels necessary.

- 4.5 To Organize Voluntary Blood Donation Camp, Blood Donation Motivation Camp, Body & Organ Donation Camp, Eye Donation Camp, Health camp, Consumer Awareness Camp, Ambulance Service etc. for the benefit of peoples. To organize, run, maintain, support, form, various types of awareness campaigning programs. To work for the rights, protections, empowerments caring & developments of women, children, youth, aged people, helpless persons, slum, sicks, Backward exploited deprived communities, tribes physically & mentally challenged people.
- 4.6 To promote in NGO activities in the areas of Adult Literacy Women Empowerment, Poverty Eradication, Child Labour Abolition, Child Marriage, Dowry demand and dowry death, Sexual harassment, Mentally challenged persons, Rehabilitation of Palsy Children, Rehabilitation of Old Age and deprived Senior Citizens, rural education, health awareness programmes on AIDS, Cancer, Thalassemia, Tuberculosis, Diabetes, Heart Diseases, Malnutrition and other critical diseases, Tribal Up-liftment and take up any other acts or actions as the case may warrant. To especially establish, maintain, Develop, promote & run rehabilitation centre & counseling the rehabilitate, Addict & Alcoholic persons.
- 4.7 To do, act, run, motivate, promote, work for development and upliftment of women for their Social identity build up, health & hygiene consciousness, Economically independent. To provide all types medical assistance, sanitary pad distribution, basic education, Science Education & Communication, skill development Training, Training on production of handloom & handmade products and also marketing in indigenous & outside market for Women's economically independent & Empowerment. To protest against domestic violence on women & give them all types support. To Promote and encourage the need for Women Empowerment particularly among the youth section.
- 4.8 To Motivate and Create Awareness, particularly woman and Children rights to the people and can even open help lines. To do, act, run, promote, work for development and upliftment of socioeconomic condition of peoples. To protest and fight against the injustice against people. To aware people about various social issues to fight against evils. To aware people about Consumer Protection Act & help the consumers to take legal action(s) through Consumer Court. To communicate and coordinate with the Govt. Local and public authorities on various issues related to development welfare and public interest on different subjects.
- To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence etc. and to give donations and other assistance in all respects to institutions, establishments or persons engaged in such relief work. To collect varieties of materials and provide that to Slums, Rural, needy, disaster affected area. To contribute donations to Government for financial aids in case of any Natural Calamities, exigency of the country etc. To Provide Financial assistance, support, start income generation program for victims families of animal attacks. To support development for the Indian Army Families of those are seriously wounded or injured & ex- army personnel & their families.
- 4.10 To establish, maintain, Develop, run or grant aid to Old Age Home, Day Care Centre, Orphanage Home. To establish, maintain, Develop, run or grant aid to homes, Short stay homes for orphans or other establishments rehabilitation and relief of Street children, Blind Children, Distressed Children, Autistic Children, Disable People and help to the poor, needy and destitute people, Orphans, widows and aged persons and to provide them education, treatment, food, clothing and/or all types of help. To give, provide under or render help and assistance in cash kind

to poor and destitute people, widows etc. To support malnourished children, tribal families, trafficked person, acid attack person or families. To establish, form, create, run and develop institutions, homes for the rehabilitation of physically handicapped and disabled men and women, or mentally retarded persons both male and female and to provide them education, food, clothing, treatment and/or all types of help. To Care and treat the sick, helpless and indigent persons, heavy smokers, drug/alcohol inebriated persons.

- 4.11 To Establish, Develop, Support, Maintain and Run Elderly and Dementia Care both Residential and Daycare under one Roof and also To Establish, Develop, Support, Maintain and Run Old Age Home, Widows Home, Ladies Hostel, 50 Bed Mini Hospital with Poly Clinic, De-Addiction Centre, Rehabilitation Centre.
- 4.12 To work for all types of animals like street dogs, cats, cow & others animals. To work for the benefit of animals, fishes & birds and make sincere efforts to protect them and give fooding, lodging and also vaccinate them for their good health and wellness. to protest against violence, torture and kill of the helpless animals. to give them all types of legal aid and protection time to time when will be needed.
- 4.13 To prepare organic fertilizer, to set up seed bank, to recycle wastewater, to recycle worn apparel, to preserve rain water, to plant nutrient plants to fertilize land, to prepare herbal pesticide, to prepare herbal disinfectants, to makeup herbal soap, to encourage the society to use eco-friendly packaging material. to developing a system for surface water management through development of amicus, check dams etc for water harvesting. to encourage the use of alternative sources of energy, like solar cooker, bio-gas, smokeless chullas etc.
- 4.14 To work, promote cottage, khadi, and traditional handicraft for development of handicraft products & organize training programme for the attached beneficiaries. to work on revival of handloom products & also to popularise handicraft products. Also work on revival of almost lost art of Bengal.
- 4.15 To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex. To work for the preservation of historical monuments, Indian Culture, education & research for the benefit of the public in general.
- 4.16 To run, publish, print, distribute and sale of News Papers, books, periodicals, leaflets, Banner, brochures, souvenirs, magazines, useful literatures, charts, issue related IEC (Information, Education and Communication) materials and other periodical illustration for generating the income for the trust for the benefit of its aims. To promote or to prepare for production of film, serial, movies for the social awareness & benefit of the people and society as whole.
- 4.17 To establish, develop, run, promote & organize gymnasiums, sports clubs physical, cultural indoor & outdoor games like Cricket, Football, Tennis playing, Swimming Pools, Self Defense Training Centers like Karate, Judo, Kung Fu & any other Sports Activities, traditional games along with the contemporary sports among youth & others. To organize Science & Nature Study Camp, Summer and/or Winter camp.
- 4.18 To establish, run, support, form, maintain and grant aid or other financial assistance to Coaching centres, Balwadi Centres, Anganwadi Centres, Basic & Adult education centres, Community learning Centres, Youth Development centres, Condensed Courses, Non Formal Education Centres, Capacity Building Training

Centres for programs, Crèches Centres, Day Care Centres, Libraries, Free Reading Rooms etc. To undertake child-centric educational activities.

- 4.19 To arrange and/or Organize Talent Search, Talent Search Examination, Seminar, Debate, Talk Show, Theater, Road Show, Rally, Quiz, Camp, Workshop, Awareness Programme among school/ college/ University Students, common people, social worker group or any other issues like Educational, Legal, Health and Cultural programme, as the Trustees may deem fit and proper at their discretion. To organize, run, maintain examine various types of tests, contests etc like IQ tests, drawing, recitation, drama, dance, education, debate and/or talent tests and to award prizes, gifts etc for the same. To promote, cultivate, foster, act, run, establish centre(s) for the promotion of Music, Dance, Folks, Arts, Dramas, Recitations and all types of Cultural Activities.
- 4.20 To establish, maintain and manage halls and hostels for the residence of students. To supervise and control the residence, to regulate the discipline of students of the School and to make arrangements for promoting their health welfare and cultural and corporate life. To establish maintain and manage residential quarters for the staff of the trust and schools.
- 4.21 To establishment of home for orphan, child care institute or home. Mobile charitable dispensary, welfare centre for mother and child, and children home (boys and girls). Organise awareness generation program on customer protection (Jago grahak Jago) throw seminar and Street theatre. To accept all shorts of schemes, projects and collaboration from state/Central social welfare department and other department of state and Central Government or semi government, corporate bodies, non government agencies for the welfare of women general people and children for the fullfillment and of the forgoing objects. To fulfill the above objects the trust.
- 4.22 To promote, establish, maintain, undertake Pathology Centre, Diagnostic Centre, Dispensary, Drug Centre, in the rural are and villages for the benefit of Needy people (Pathology, X-ray, ECG, USG, MRI, CT Scan Machine etc.) with free of cost or subsidized rate.
- 4.23 To establish, run, manage hospitals, health centres, mobile health clinics, research centre(s) to provide health care, counseling and referral services for all kinds of illness and diseases.
- 4.24 To establish, develop, maintain, run and grant aid in cash or in kind to Hospitals, Medical schools, Medical colleges, Homoeopathic Medical College and Hospital, Yoga College, Ayurvedic Colleges, Ayurvedic Hospitals, Herbal or Homoeopathic Medicines Manufacturing Unit, Nursing Colleges, Nursing institutions, Dispensaries, Maternity Homes, Pharmaceutical College, Para Medical College, Nursing & Paramedical Training Centre, Diagnostic Centre, Radiological Imaging Centre, Health check-up centres, Child welfare centres and/or such other similar charitable institutions in India for the benefit and use of the general public.
- 4.25 To promote traditional therapies like Homoeopathy, Yoga, Naturopathy, Meditation, Acupressure, Acupuncture, Massage Therapy, Ayurveda, Panchakarma, Reiki etc.
- 4.26 To establish, develop, maintain, run and to do all kinds of Agricultural activities, Pisciculture activities, Apiculture projects and to help the agro based industries like Green House, Mushroom, spawn production Laboratories, plant breeding centre, nurseries, floriculture, horticulture, bio fertilizer plant, medicine plants, coconut plantation, Pearl Farming, industries and required based training programme for the farmers of those sectors. To profess and undertake sustainable Agriculture

development activities involving Organic farming, integrated farming, nutritional garden, medicinal plantation, water shed management, rain water harvesting etc. To promote and protect natural herbs and plants by cultivation, preservation, storage, processing, demonstration, creating botanical garden and providing necessary training. To establish, maintain, run, promote on Farmers Development, Farmers Insurance, Organic Cultivation & Organic Smart Village Processing, Organic Fertilizer Manufacturing, Agro Related Industry. To Set up Schools on Agricultural Training, Agro Farming & Import Export Training. To work on conservation & Management of Natural Resourses.

- 4.27 To set up, run, promote, maintain Farm House, Poultry, Hatchery, Dairy, Fishery, Animal Husbandry, Bee Cultivation etc for production of Milk, Meat & Honey to support agriculture and research on agriculture, Orchards and Floriculture and all. To open, found, established, promote, setup, run FMCG processing, manufacturing, packaging, distribution & marketing.
- 4.28 To establish, maintain, run, promote for the establishment and/or maintenance of parks, gardens, forests, playground for use by public in general by purchasing lands, taking lease from any Government and/or Private institutions or organizations.
- 4.29 To establish, develop, run, promote, form self help groups of men and women both and to assist and help them for all type Self-Help income generating program(s) in the field to uplift of poor people of the members of Self-Help Groups (SHGS). To form women groups, youth groups, self help groups; old aged groups, adolescent groups, children groups/clubs, community leaders groups and group of volunteers etc.
- 4.30 To accept donation, grants, presents, recurring, deposits from members and non members, both secured and unsecured loans from any Bank (s), Financial institution (s), any company, Firm, Trusts, subscriptions and other offerings and to deal with the same for the purposes of fulfilling the objects of the Trust in proper legal norms and valid documents/receipt.
- 4.31 The Trust can assign/delivered/provide to open it's Branch/Brances in various Places in any field like education, health, Agriculture, Art & Culture, science & technology, literature, commerce, management and any others Programme which mentioned in the Trust Deed.
- 4.32 The Trust can assign/delivered/provide/ give all and/or any types of membership like. Honorary Member, Ordinary Member, General Member, Life Member and also form and/or appoint different types of Committee and Sub-Committee. To take donation, subscription from its members and /or non-members in proper legal norms and valid documents/receipt.
- 4.33 To take or collect donations/ gifts/ subscriptions/ Membership Fees/ grants/ property etc. from anybody, other organizations, Government, non-Government, corporate sectors and from others in proper legal norms and valid documents/receipt.
- 4.34 To engage in any other Non Profiteering Activities and/or Business as and when it deems fit. And also this Organization Called as a NGO. To work & act as a NGO and gives membership facilities and form committee(s) / Branch(s).
- 4.35 To acquire, purchase or otherwise own or under lease or hire temporarily or permanently and movable or immovable property necessary or convenient for the furtherance of the objects of the trust.
- 4.36 To construct repair and manage the marghats, cemeteries and burial grounds etc.

- 4.37 To collect funds or donations from govt. department elected member like MP, MLA, Counselor, corporate sector, non-govt. organization or anybody for land/property purchase or construction of School Building, Hostel, seminar hall, auditorium, library room or any other purposes in proper legal norms and valid documents/receipt.
- 4.38 To foster the spirit and spread ideals of Understandings, Unity And Brotherhood among the people at large of different Castes, Creeds, Religions and Sex and to promote national integration amongst them and to work for the Eradication and Elimination of Social Evil and Superstitions.
- 4.39 To fulfill basic objects of the trust, it will be liberty to collect/donation/grants/loans/distribute any fund and/or funds as per provision of the Negotiable Instruments Act, 1881, The Reserve Bank of India Act, 1934, The banking Regulation Act, 1949, the Income Tax Act, 1961, or the rules or regulation made there under shall have the meanings respectively assigned to them in those acts or the rules or the regulations.

5. BOARD OF TRUST:-

All the Properties of the Trust shall remain vested with the Board of Trustees (hereinafter referred to as the Board) which shall consists of not less than 2 (Two) Trustees and not more than 11 (Eleven) Trustees. If the number of the trustees shall fall below two, the Trustees shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.

6. POWER OF TRUSTEES:-

- a) To accept any donation, deposit, contribution, grant or subscription in cash or in kind, from any person(s), body of persons or trust, with or without conditions in proper legal norms and valid documents/receipt.
 - ***To maintain a fund which shall include
 - i)All fees and other charges received by the trust.
 - ii) all money received by the trust by way of grants, gifts, donations, benefactions, bequests or transfers, provided that no benefactions shall be accepted by the trust, which in its opinion involves conditions or obligations opposed to the spirit and objects of the trust.
 - iii). All money received by the trust in any other manner or from any other source.
- b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- c) To convert and deal with the trust property and/or any investments for the time being.
- d) To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees for the benefit of the Trust as per Income Tax 1961 & SEBI Circular 2017.

- e) To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund to get permission from committee as per as per getting the permission from Court.
- f) To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- g) The Trust may open Bank Account(s) in any Bank and/or Banks in the name of "NAGARIK ADHIKAR RAKSHA SANGATHAN" and/or any other institution(s) / Organization(s) governed by this Trust. Such account (s) will be operated by any Two Trustee in between the Trustee(s) of the Trust.
- h) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- i) To appoint or make provision for the appointment of any person (including all or any of the Trustees and committees or administrator or Chairman cum Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
- j) To engage and/or appoint Experts And Officers, Teachers, Professors, Instructors, Employee Staff and other Employees, Servant and Agents for the purposes of the Trust and its Projects and to Pay their Salaries, Wages And Remunerations. To do all such acts, deeds, writes and things as may be deemed identical or conducive to the foregoing objects.
- k) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- m) To set apart and/or allocate the whole or a part of the income or the corpus of the trust Fund or part thereof for any of the objects of the Trust.
- n) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- o) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, Organizations or Trusts to start maintain, or carry out such charitable objects.
- **p)** To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

- q) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.
- r) To take over or amalgamate with any other charitable trust, society, association, or institution with similar objects.
- s) To establish, promote, manage, organize or maintain or to assist in establishing, promoting, managing, organizing, or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.
- t) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- u) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- v) To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the trust, societies, institutions or associations with which this Trust is authorized to amalgamate similar type Trust.
- w) To transfer and hand over the Trust to any other Society, Corporation, Institution, Trust or Organization in similar type nature on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the Society, Corporation, Institution, Trust or Organization with the powers, provisions, agreements and declarations, appearing and contained in these presents subject to such modifications as may be necessary and consequent to such transfer of the Trust fund. The Trustees for the time being of these presents shall become discharged from the Trust thereof relating to Trust Funds so transferred.
- APPOINTMENT OF NEW TRUSTEES:- it is agreed that if the Trustee sees fit he may appoint an additional Trustee to be Trustee of the Trust. Change of Trustees it is agreed that if the Trustee becomes unable or unwilling to act as Trustee of the Trust he or his lawful representative may appoint a new Trustee to be Trustee of the Trust provided that this new Trustee shall accept his appointment.
- y) DELEGATION OF POWER:- The Trustee shall have the power to delegate the administration of the Trust to any third party which he in his absolute discretion shall see fit provided always that the Trustee remains responsible for the actions of any party to whom he has delegated authority as per sec-47 if permits.
- z) The Trustees shall not collect any money from the general public and/or open market by using the Trust name and misguiding and provoking any gainful profit which is illegal and in such case the Trust & Trustees come under the punishable law like PMLA, IPC, CRPC and other relevant law and the Trust is void as per Sec-4.

7. DUTIES OF THE OFFICE BEARERS:-

CHAIRMAN / PRESIDENT:

i). The Chairman / President will preside over the meeting of the Trust.

- ii). Take all disciplinary actions such as suspend, removal, dismissal of the employees of the Trust in case of any illegal activity which is contrary of the trust etc. in consultation of the Board of Trust.
- iii). Sign on behalf of the Trust for all sums received as subscription, donation etc.
- iv). Advice to the Secretary in any matter requiring urgent attention, and Call emergent meeting.
- v). Sign and give pay orders on all bills or Payments.

SECRETARY:

i). Convene all meetings of the Trust and maintain minute books of all meetings.

ii). Issue general circulars and notices.

- iii). Receive all applications for membership which shall me placed before the Board of Trust.
- iv). Get the accounts of the Trust audited by a Chartered Accountant.
- v). Ensure compliance with statutory requirement and transact all other business subject to the direction of the Board of Trust.

TREASURER:

- i). Collect and receipts all sorts of subscriptions, donations and deposit of money and grant receipts thereof.
- ii). Maintain and keep cash book and such other accounts as are necessary.
- iii). Prepare the budget in consultation with the Secretary for consideration of the Board of Trust.
- 8. That the Trust Fund may be augmented by the income from the initial fund and also by donations, subscriptions and other contributions from time to time.
- 9. That the Trust Fund shall not be applied for any purpose other than those specified in Para 4 hereinabove.
- 10. That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the trust.
- 11. The Trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omissions or commissions of the other trustees, nor of any banker or other person with whom the trust properties or any securities may have been deposited or kept.
- 12. The Chairman cum managing trustees for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on -such terms as to retirement and re-appointment as the trustees for the time being considered proper. A person shall cease to be a Trustee either: (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or(ii) if he is requested to resign by 3/4th or as near thereto as possible of the remaining Trustees.

- 13. Every Trustee will be at liberty to resign on giving one month's notice of his intention to-do so.
- 14. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:
 - a) Two Trustees shall form a quorum for a meeting of the Trustees.
 - b) All matters will be decided mutually by the Trustees.
 - c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
- 15. The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorise the Trustees to spend the income or corpus of the Trust for any purpose not authorised by these presents.
- 16. The accounting year of the Trust shall be the financial year ending on 3lst March every year.
- 17. The office of the Trust shall be situated at any Place and / or Places in India as may be mutually agreed upon and may think fit by the Trustees by two thirds majority.
- 18. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any Purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.

FUNCTION OF THE TRUST:

- a) The Trust will never acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country. Sec-4 for which the Trust and the Trustees are responsible for that and come under the all punishable law (CRPC and IPC).
- b) The Trust will never acts like Micro Financing and Money Laundering (Act-2012) Economic offence / crime in connection with sec-20 and in nature and shall not obtain any donation or like that from abroad without getting permission of FCRA (Foreign Contribution Regulation Act) from the central Govt./the competent Govt. Authority which the Trust and the Trustees are responsible for that and come under the all punishable law(CRPC and IPC).
- <u>c)</u> The Trust shall never augment and/or borrow money from the public or open market by announcing attractive financial scheme.
- d) All donation & Gift from any one individual or Institution or any corner shall be accepted by maintaining all legal norms and valid documents/receipts.

BENEFICIARY:

The Trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of caste, religion or sex, colour or place of birth the General public and community at large (the beneficiaries).

DISSOLUTION:

In the event of dissolution of the Trust, the entire Trust funds shall be realized and first be used for payment of liabilities of the Trust. The Trust assets left if any, shall be disbursed to other Trust or Associations having similar objectives after obtaining previous approval of Commissioner of Income Tax and in no event it shall be distributed in any manner, to any of the Board of Trustees or their relatives or related concern.

AREAOF JURIDICTIONS OF OPERATION:

Area of jurisdictions / operation of the Trust in the whole of India but preferably in the state of West Bengal and particularly in the limits of Kolkata Municipal Corporation.

REMUNARATION OF THE TRUST:

The Trustee will not be able to entitled to receive/get any remuneration as Trustee but may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto subject to passed by the Board of Resolution and approved by the income tax department.

APPLICABILITY OF THE TRUST:

The Provisions of The Indian Trust Act 1882, The Provisions Of The Charitable And Religious Trust Act 1920 shall apply to all Matters not Specifically Mentioned in these Presents violating the same in any part, the whole trust is void.

LAWFUL PURPOSE:

APPLICATION OF INCOME TAX:

To perform that notwithstanding herein contained in the income as the corpus OF THE TRUST fund the same shall be applicable and applied to for PUBLIC CHARITABLE PURPOSE ONLY within such territories and subject to such conditions or limitation if any as may from time to time be laid down by the Income Tax Act, 1961 or Any other Acts governing taxation of income the wealth of PUBLIC CHARITABLE TRUST so as to render the TRUST hereby established as well as its income eligible for exemption from taxation under such Act or Acts, now or prevailing or any modification replacement thereof.

All clauses herein are intended to secure exemption from Income Tax on the income of contributions and donations to the trust and any clause or portion of this deed of Trust which is inconsistent with or repugnant to the section of the Income Tax Act, 1961as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.




